Sir/Madam,

This is with reference to the proposal submitted by Patna Women's College, Avila Convent, Bailey Road, Patna, Bihar-800 001 affiliated to Patna University, Patna under the UGC Scheme for Autonomous Colleges.

I am directed to convey that the Commission at its meeting held on 22.12.2017 decided to grant of autonomous status to Patna Women's College, Avila Convent, Bailey Road, Patna, Bihar-800 001 affiliated to Patna University, Patna for a period of ten years w.e.f. 2018-2019 to 2027-2028.

Patna University, Patna-800 005 Bihar may issue necessary notification/order regarding the grant of autonomous status to the college as per the UGC Guidelines for Autonomous Colleges. The college, if eligible, shall apply for autonomy grant as per the norms laid down in the Guidelines.

The autonomous college shall be guided by the provisions of the UGC Guidelines for Autonomous Colleges. The Guidelines are available on the UGC website, www.ugc.ac.in. However, the college may take special note of the following:


- (d) The college will constitute the Internal Quality Assurance Cell (IQAC) under intimation to UGC. The Cell will have an external Peer Team comprising of academicians of repute and will send report to UGC regarding the performance of the college. The report will also be put on public domain on the website of the College. The external peer review shall be conducted atleast once in a year.

: 2 :

- (e) If the college is currently accredited by NBA only, it must undergo NAAC accreditation within two years of conferment of the autonomous status.
- (f) The college will apply to University Grants Commission for extension of autonomous status six months prior to expiry of the autonomy cycle. If the college does not apply within the stipulated time, University Grants Commission will be at liberty to withdraw the autonomous status of such college.
