





GENERAL RULES



1. THE COMPETITION IS FOR INDIVIDUAL PARTICIPANTS ONLY.
2. PRE-REGISTRATION IS MANDATORY. NO ON-THE-SPOT REGISTRATIONS WILL BE ACCEPTED. EACH PARTICIPANT CAN ONLY REGISTER ONCE.

PERFORMANCE RULES

1. THE PARTICIPANTS WILL BE PAIRED: ONE TO SPEAK FOR THE MOTION AND ONE TO SPEAK AGAINST THE MOTION.
 2. THE COMPETITION WILL FOLLOW AN ELIMINATION FORMAT, WITH TEAMS PROGRESSING THROUGH ROUNDS BASED ON THEIR PERFORMANCE. THE NUMBER OF ROUNDS WILL DEPEND ON THE TOTAL NUMBER OF PARTICIPATIONS.
 3. EACH SPEAKER WILL HAVE 3 MINUTES TO PRESENT THEIR ARGUMENTS. AFTER THE OPENING SPEECHES, EACH SPEAKER WILL BE GIVEN 1 MINUTE FOR REBUTTAL TO COUNTER THE OPPOSING TEAM'S ARGUMENTS.
 4. JUDGES OR THE OPPOSING TEAM MAY ASK 1-2 QUESTIONS TO EACH SPEAKER, FOR WHICH THEY WILL HAVE 1 MINUTE TO RESPOND.

5. PARTICIPANTS CANNOT BRING PREPARED SPEECHES. USE OF WRITTEN NOTES DURING THE DEBATE IS NOT ALLOWED.
 6. THE FIRST SPEAKER WILL PRESENT THEIR ARGUMENT, FOLLOWED BY ANOTHER SPEAKER. THE REBUTTALS WILL FOLLOW THE SAME ORDER.
 7. STRICT ADHERENCE TO TIME LIMITS WILL BE MAINTAINED. EXCEEDING THE TIME LIMIT WILL RESULT IN POINT DEDUCTIONS.
 8. ARGUMENTS MUST FOCUS ON THE TOPIC AND SHOULD NOT INCLUDE PERSONAL ATTACKS ON THE OPPOSING TEAM.
 9. NO ELECTRONIC DEVICES (PHONES, LAPTOPS, ETC.) WILL BE ALLOWED DURING THE DEBATE. ALL ARGUMENTS MUST BE PRESENTED VERBALLY.

MISCELLANEOUS

1. THE DECISION OF THE JUDGES IS FINAL AND BINDING. NO APPEALS OR DISPUTES WILL BE ENTERTAINED.
 2. NO OFFICIAL REHEARSALS WILL BE PROVIDED. INDIVIDUALS ARE EXPECTED TO PRACTICE ON THEIR OWN.
 3. THE DEBATE WILL BE CONDUCTED IN HINDI. ALL PARTICIPANTS ARE EXPECTED TO PRESENT THEIR ARGUMENTS IN HINDI.
 4. PARTICIPANTS ARE REQUESTED TO JOIN THE WHATSAPP GROUP WHICH WILL BE CREATED AFTER THE REGISTRATIONS FOR ALL THE NECESSARY FUTURE UPDATES.
